### Key Responsibilities:

- Conducting baseline survey/village study to identify the activity and what can be done through aggregation and prepare a feasibility report.
- Mobilisation of farmers to form Farmers Interest Groups (FIGs) and Farmer Producer Organizations (FPO).
- Organise Training of farmers from FIGs, identify opinion leaders at village level, discussion with village community and support Project Management Unit PMU) to organize exposure visits, agriculture technology demonstrations for member farmers.

The Manager shall be involved in all the activities related to or aiming at responsibilities mentioned above.
